# Summary of the Results

### Summary of the Results in 2009

The sales (income) and number of persons working at the location of establishment<sup>1)</sup> etc. on the service industries<sup>2)</sup> in 2009 were as follows.

- 1) Persons working at the location of establishment include all persons who are engaged in the business of the establishment at the end of business day of the month, excluding dispatched or subcontracted employees to separately operated establishment, but including those who work as dispatched or subcontracted employees from separately operated establishment. The same shall apply hereinafter.
- 2) Service industries covered the 9 industries classified in the following groups designated by the Japan Standard Industrial Classification (Rev.12, November 2007): "Information and communications", "Transport and postal activities", "Real estate and goods rental and leasing", "Scientific research, professional and technical services", "Accommodations, eating and drinking services", "Living related and personal services and amusement services", "Education, learning support", "Medical, health care and welfare" and "Services, n.e.c.". The same shall apply hereinafter. Please refer to the appendix 5 for details of industry coverage.


#### 1 Sales (Income)

Total sales (income) of service industries in 2009 was 290.5 trillion yen.

When we look at the composition of the previously mentioned industries, we find that "Transport and postal activities" was the highest at 16.1% (46.7 trillion yen) and "Education, learning support" was the lowest at 1.3% (3.7 trillion yen).

Total sales (income) of service industries in FY2009 was 289.1 trillion yen.

## 2 Sales (Income) per Establishment

Total sales (income) per establishment for the service industries in 2009 was 103.6 million yen.

By industry, "Information and communications" with 667.8 million yen was the highest among the 9 industries.

Total sales (income) per establishment for the service industries in FY2009 was 103.1 million yen.


## 3 Number of Persons Working at the Location of Establishment

The number of persons working at the location of establishment (annual average) was 26.4 million persons in 2009.

When we look at the composition of industries, "Medical, health care and welfare" (23.8%, 6.3 million persons) was the highest, followed by "Accommodations, eating and drinking services" (18.9%, 5.0 million persons). The two industries accounted for nearly 40% of the total.

The number of persons working at the location of establishment (fiscal year average) was 26.4 million persons in FY2009.

## 4 Sales (Income) per Persons Working at the Location of Establishment

Total sales (income) per persons working at the location of establishment was 11.0 million yen in 2009. By industry, "Real estate and goods rental and leasing" was the highest at 24.8 million yen. "Information and communications" was the second highest at 24.0 million yen.

Total sales (income) per persons working at the location of establishment was 11.0 million yen in FY 2009.

Figure 3 Change in Monthly Sales (Income)




Figure 4 Change in Monthly Number of Persons Working at the Location of Establishment
