- Establish a statistical database of "Statistical data producer units"
- Establish database of entrepreneurs operating and providing services which are not available to evaluate its revenue every time
- Identify the activity scope of the sample survey

- Administration classification, Classification of all economic activities
- 4.0, Enforce updated classification of type of enterprise and ownership
- Compilation of Classification of the purposes of Non-Profit Institutions Serving Households (COPNI)
- Establish a statistical unit in consistence with International standard
- Establish a geographical database on website
- Identify the activity scope of the sample survey







# Establishment Census

# Comparison between 2006 and 2011 Establishment Censuses Scope of work:

- ownership, its branch offices and units operating on the territory of Mongolia
- Private enterprises of which incomes are not obtainable to estimate every time
- Establishments of all types of Establishments of all types of ownership, its branch offices and units operating on the territory of Mongolia



#### Importance:

- Location and activity direction of entities which are registered to operate business on the territory of Mongolia were accurately determined
- An opportunity to substantially determine the contribution of entities to national economy was created
- Usage of census data has been increased for the reason that beyond the indicators of entities, number of employees, sales revenue and its capital, investment size and the indicators of information technology have been included in the census questionnaire
- For the first time a geographical database of the census results has been established



#### Importance:


- An opportunity to generate the government program and policy to successfully coordination of activity directions, location and centralization of the entities was created
- On the basis of geographical database, census data has become fundamental database for local and regional development policies
- Introduction of International Standard Industrial Classification of All Economic Activities (4.0) has become a background data for compilation of 2008 SNA
- Advancements on compiling GDP, Input and Output Table and other indicators of SNA as well as improving the quality of data

#### 4. Comments and the issues needed for further action

- To precisely define the scope of sample survey through investigation of missing entities registered in the State Registration Authority, entities with missing address data, not accessible and non operating
- To open up the opportunity to disseminate the data to the users as promptly as possible by updating the bussiness register database
- An updated indicators of the business register database is required to combine with the geographical database and develop a prospect for the policy planning and development



#### 4. Comments and the issues needed for further action

- To enrich the census result with a quarterly data of business register and annual sectoral data on a regular basis
- Regularly develop source of data from State Registration Authority, General Department of Taxation, State Property Committee
- To reflect amendment on register and abolish the legal body in relevant legislative acts of registration of legal bodies as well as develop and provide comments on its improvements
