- Accommodation and Food service activity (ISIC 55 -56)


- Mining and Quarrying establishments that sell their products after mined or quarried.
- Manufacturing establishments that sell the products they manufactured such as
 - Food processing shop
 - Bakery
 - Wine producers and shop
 - Tailor shop (making clothes and dress)
 - Photocopy shop
 - Shop to reproduce CD/DVD/video
 - > Shop manufacturing products, regardless of your own request or not (furniture, container, fence...)
 - All kinds of repair shop of manufactured products
 - Recycling shop
 - Electricity distributor
 - Water supplier
 - Sewerage or waste collector
 - Wholesale establishments that can sell to retail consumers
 - Hotel or guesthouse
 - Restaurants / catering shop

2. Overview of industries

2.1 Mining & quarrying

Mining and quarrying include the extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction can be achieved by different methods such as underground or surface mining, well operation, seabed mining etc.



2.2 Manufacturing

Manufacturing includes the physical or chemical transformation of materials, substances, or components into new products, although this cannot be used as the single universal criterion for defining manufacturing. The materials, substances, or components transformed are raw materials that are products of agriculture, forestry, fishing, mining or quarrying as well as products of other manufacturing activities. Substantial alteration, renovation or reconstruction of goods is generally considered to be manufacturing.
