- 1) 人口及び市町村の数は沖縄県を含まない。年齢は数え年である。
- 2) 大正9年～昭和15年には、旧東京府小笠原島の南鳥島及び沖縄県島尻郡の鳥島の面積は含まれていない。  
昭和25年～平成22年の都道府県又は当該県下の市町村をまたがる所属未定の湖沼等の面積は全国に含まれているが、市部又は郡部には含まれていない。  
昭和30年～平成22年の市部及び郡部の面積は、一部境界未定のため、総務省統計局において推定した。
- 3) 昭和20年以降の人口密度については、歯舞群島、色丹島、国後島、択捉島及び竹島の面積を除いて算出した。

- 9) 沖縄県の外国人を除く(沖縄県の70歳以上の外国人人口は、男55人、女81人)。

- 2) The areas of Minamitori-shima in Ogasawara, Tokyo-fu and Tori-shima in Shimajiri-gun, Okinawa-ken are not included in "Area" from 1920 to 1940.  
The areas of lakes and marshes whose boundaries on the water are uncertain among several prefectures or among several municipalities are included in "Japan", but not included in "All shi" nor "All gun" from 1950 to 2010.  
The areas of all shi and all gun from 1955 to 2010 were estimated by Statistics Bureau, Ministry of Internal Affairs and Communications, because of the partial uncertainty of boundaries.
