## Simple questions

In addition to filling out the questionnaire form, there is a few simple questions. We ask that you answer these questions as well.

《Your personal information will be protected.》

- The answers are never used for other purpose such as immigration control or police investigations.
- For the Post Enumeration Survey of the 2025 Population Census, strict protection of personal information is stipulated by the “Statistics Act”.
- Persons engaged in the investigation (e.g. staff of the Implementation Secretariat) are obliged to maintain confidentiality.
- All communications during Internet responses are encrypted (SSL/TLS format). Measures to prevent unauthorized access are implemented 24 hours a day.
