Summary of the Result of 2019 Economic Conditions Survey- Third Tabulation

Tabulation on establishments

The third tabulation targets establishments under enterprises belonging to the service industry*. The tabulation results by industry do not cover all establishments in Japan belonging to each industry.

1. Sales by prefecture and Industry

Looking at sales by industry concerning establishments under target enterprises for tabulation, sales in "Wholesale and retail trade" were the largest in Tokyo at 151.3332 trillion yen, followed by Osaka at 45.6049 trillion yen, and Aichi at 34.8992 trillion yen. Concerning "Medical, health care and welfare," sales were the largest in Tokyo at 24.6975 trillion yen, followed by Osaka at 7.8555 trillion yen, and Kanagawa at 6.2946 trillion yen. Concerning "Real estate and goods rental and leasing," sales were the largest in Tokyo at 19.3723 trillion yen, followed by Osaka at 5.4576 trillion yen, and Kanagawa at 2.8459 trillion yen (Table 1).

2. Annual sales amount of goods by prefecture, wholesale trade, and retail trade

Looking at the annual sales amount of goods by prefecture concerning "Wholesale and retail trade" out of the establishments under the target enterprises for tabulation, the amount in "Wholesale trade" was the largest in Tokyo at 126.2244 trillion yen, followed by Osaka at 34.3979 trillion yen, and Aichi at 25.1616 trillion yen. Concerning "Retail trade," the amount was the largest in Tokyo at 19.8532 trillion yen, followed by Osaka at 9.8672 trillion yen, and Kanagawa at 9.0263 trillion yen (Table 2).

3. Annual sales amount of goods by Group (wholesale and retail trade)

Looking at the annual sales amount of goods in "Wholesale and retail trade" by group out of establishments under the target enterprises for tabulation, the amount in "Wholesale trade" was the largest in "Wholesale trade (food and beverages)" at 37.3602 trillion yen, followed by "Agricultural, livestock and aquatic products" at 31.2645 trillion yen and "Electrical machinery, equipment and supplies" at 30.9898 trillion yen. Concerning "Retail trade," the amount was the largest in "Grocery stores" at 21.8233 trillion yen, followed by "Motor vehicles" at 18.4936 trillion yen, and "Medicine and toiletry stores" at 13.7075 trillion yen (Table 3-1, Table 3-2).
