Tabulation on establishments

The third tabulation targets establishments under enterprises belonging to the service industry*. The tabulation results by industry do not cover all establishments in Japan belonging to each industry.

* It refers to the tertiary industries, including wholesale trade, retail trade, finance, etc.

1. Sales by prefecture and industry

Looking at sales by prefecture and industry concerning establishments under target enterprises for tabulation, sales in "Wholesale and retail trade" were the largest in Tokyo at 143.4432 trillion yen, followed by Osaka at 44.4460 trillion yen, and Aichi at 34.0198 trillion yen. Concerning "Medical, health care and welfare," sales were the largest in Tokyo at 24.8539 trillion yen, followed by Osaka at 8.1354 trillion yen, and Kanagawa at 6.5559 trillion yen. Concerning "Real estate and goods rental and leasing," sales were the largest in Tokyo at 19.6143 trillion yen, followed by Osaka at 5.6461 trillion yen, and Kanagawa at 2.8159 trillion yen (Table 1).

2. Annual sales amount of goods by prefecture (wholesale and retail trade)

Looking at the annual sales amount of goods by prefecture concerning "Wholesale and retail trade" out of the establishments under the target enterprises for tabulation, the amount in "Wholesale trade" was the largest in Tokyo at 118.3740 trillion yen, followed by Osaka at 33.1367 trillion yen, and Aichi at 24.1228 trillion yen. Concerning "Retail trade," the amount was the largest in Tokyo at 19.9740 trillion yen, followed by Osaka at 9.8115 trillion yen, and Kanagawa at 9.0903 trillion yen (Table 2).

3. Annual sales amount of goods by Group (wholesale and retail trade)

Looking at the annual sales amount of goods in "Wholesale and retail trade" by group out of establishments under the target enterprises for tabulation, the amount in "Wholesale trade" was the largest in "Wholesale trade (food and beverages)" at 36.7456 trillion yen, followed by "Electrical machinery, equipment and supplies" at 30.8134 trillion yen and "Agricultural, livestock and aquatic products " at 30.5126 trillion yen. Concerning "Retail trade," the amount was the largest in "Grocery stores" at 21.7612 trillion yen, followed by "Motor vehicles" at 19.0424 trillion yen, and "Drug and toiletry stores" at 14.4739 trillion yen (Table 3-1, Table 3-2).
