

Division F – ELECTRICITY, GAS, HEAT SUPPLY AND WATER

Overview of the Major group

This Division comprises establishments engaged in providing electricity, gas, heat or water (excluding water for irrigation), and those engaged in the treatment and the like of wastewater and rainwater.

“Electricity” includes establishments engaged in supplying electricity in response to general demand or those engaged in supplying electricity to such establishments, and those engaged in supplying electricity in response to demand at a specified service point. Establishments engaged in generating power for their own use are also included in “Electricity”.

“Gas” includes establishments engaged in piping manufactured gas, natural gas or mixtures of both in response to general demand and those engaged in piping gas using pipes of a certain size or larger that they maintain and operate themselves.

“Heat supply” includes establishments engaged in supplying thermal energy or steam through the medium of steam, hot water or cold water, or in supplying hot water by pipes, in response to general demand.

“Water” includes establishments engaged in supplying water, in response to general demand, using water mains or pipes and other facilities, and those engaged in removing or treating wastewater and rainwater by means of public drains, river-basin drains or urban drains.

Major group 33 – PRODUCTION, TRANSMISSION AND DISTRIBUTION OF ELECTRICITY

Overview of the Major group

This Major group comprises establishments engaged in supplying electricity in response to general demand or those engaged in supplying electricity to such establishments, and those engaged in supplying electricity in response to demand at a specified service point.

Establishments engaged in generating power for their own use are also included in this Major group.

3300	Head offices primarily engaged in managerial operations

This refers to the establishments, as the head offices primarily engaged in controlling establishments of production, transmission and distribution of electricity, engaged in the operations except the work-site operations, for managing and controlling operations across the whole organization to promote the management of the own company, personnel affairs/personnel training, general affairs, financial affairs/accounting, legal affairs, intellectual property management, planning, public information/advertising, investigation/research and development, production/project management, real estate management, information system management, management of equipments and materials, buying/raw materials purchase, service/material procurement.

3309	Miscellaneous establishments engaged in administrative or ancillary economic activities

This refers to the establishments engaged in support operations of transportation, cleaning, repair/maintenance, preservation, to other establishments belonging to the same enterprise to primarily promote activities in the production, transmission and distribution of electricity.

331	PRODUCTION, TRANSMISSION AND DISTRIBUTION OF ELECTRICITY

3311	Electric power generation
------	---------------------------

This class comprises establishments engaged in generating and discharging electricity by using electric structures (for electricity generation or storage) maintained and operated by the business operators for electricity retail, general electricity transmission and distribution, electricity distribution or specified electricity transmission and distribution, or for private use or for a specified service.

However, this class does not include establishments engaged in isolated island service through general electricity transmission and distribution.

3312 Electric power transmission and distribution

This class comprises establishments engaged in a cross-area wheeling service, intra-area wheeling service or electricity quantity adjustment service in their service areas by using electric structures (for electricity transmission or distribution) maintained and operated by the business operators (excluding the part of such establishments that is engaged in electricity generation).

This class also includes establishments engaged in isolated island service, last resort service, or specified electricity transmission and distribution.

3313 Retail sale of electric power

This class comprises establishments engaged in electricity retail services.

However, this class does not include the parts of such services that involve general electricity transmission and distribution, specified electricity transmission and distribution or electricity generation.

3314 Electricity wholesale supply

This class comprises establishments engaged in supplying electricity aggregated by instructing those who can supply electricity (excluding electricity generation utilities) to generate or discharge electricity for electricity retail, general electricity transmission and distribution, electricity distribution, specified electricity transmission and distribution or specified electricity wholesale supply.

Major group 34 – PRODUCTION AND DISTRIBUTION OF GAS

Overview of the Major group

This Major group comprises establishments engaged in piping manufactured gas, natural gas or mixtures of both in response to general demand and establishments engaged in piping gas using pipes of a certain size or larger that they maintain and operate themselves.

Establishments engaged in the collection of natural gas are classified in the Division C –MINING AND QUARRYING OF STONE AND GRAVEL [0532].

3400	Head offices primarily engaged in managerial operations

This refers to the establishments, as the head offices primarily engaged in controlling establishments of production and distribution of gas, engaged in the operations except the work-site operations, for managing and controlling operations across the whole organization to promote the management of the own company, personnel affairs/personnel training, general affairs, financial affairs/accounting, legal affairs, intellectual property management, planning, public information/advertising, investigation/research and development, production/project management, real estate management, information system management, management of equipments and materials, buying/raw materials purchase, service/material procurement.

3409	Miscellaneous establishments engaged in administrative or ancillary economic activities

This refers to the establishments engaged in support operations of transportation, cleaning, repair/maintenance, preservation, to other establishments belonging to the same enterprise to primarily promote activities in the production and distribution of gas.

341	PRODUCTION AND DISTRIBUTION OF GAS

3411	Manufacture of gas
------	--------------------

This class comprises establishments engaged in manufacturing gas by using

liquefied gas storage facilities that they maintain and operate themselves.

However, establishments engaged in supplying natural gas that they have collected themselves through pipelines are classified under Division C – MINING AND QUARRYING OF STONE AND GRAVEL [0532].

3412 Gas pipelines

This class comprises establishments engaged in a transportation service in their service areas or at a specified service point via pipelines that they maintain and operate themselves.

3413 Retail sale of gas

This class comprises establishments engaged in a gas retail service via pipelines (excluding the parts of the service that constitute a general gas pipeline service business, specified gas pipeline service business or gas manufacturing business).

Major group 35 – HEAT SUPPLY

Overview of the Major group

This Major group comprises establishments engaged in supplying thermal energy or steam through the medium of steam, hot water or cold water, or in supplying hot water by pipes, in response to general demand.

This refers to the establishments, as the head offices primarily engaged in controlling establishments of heat supply, engaged in the operations except the work-site operations, for Managing and controlling operations across the whole organization to promote the management of the own company, personnel affairs/personnel training, general affairs, financial affairs/accounting, legal affairs, intellectual property management, planning, public information/advertising, investigation/research and development, production/project management, real estate management, information system management, management of equipments and materials, buying/raw materials purchase, service/material procurement.

3509	Miscellaneous establishments engaged in administrative or ancillary economic activities

This refers to the establishments engaged in support operations of transportation, cleaning, repair/maintenance, preservation, to other establishments belonging to the same enterprise to primarily promote activities in the heat supply.

351	HEAT SUPPLY

3511	HEAT SUPPLY

This class comprises establishments engaged in supplying thermal energy or steam through the medium of steam, hot water or cold water generated by means of boilers, freezers, etc., or in supplying hot water by pipes, in response to general demand.

However, establishments that own hot spring sources and supply hot spring water to inns, etc., are classified under Division R – SERVICES, N.E.C. [9299].

Major group 36 – COLLECTION, PURIFICATION AND DISTRIBUTION OF WATER, AND SEWAGE COLLECTION, PROCESSING AND DISPOSAL

Overview of the Major group

This Major group comprises establishments engaged in supplying water, in response to general demand, using water mains or pipes and other facilities, and those engaged in removing or treating wastewater and rainwater by means of public drains, river-basin drains or urban drains.

3600	Head offices primarily engaged in managerial operations
------	---

This refers to the establishments engaged in the operations except the work-site operations, as the head offices primarily engaged in controlling establishments of water for end users, water for industrial users and sewerage, for managing and controlling operations across the whole organization to promote the management of its own company.

In addition, the establishments of prefectural governments, cities, towns and villages which give guidance and supervision on collection, purification and distribution of water, and sewage collection, processing and disposal are also included in this classification.

3609	Miscellaneous establishments engaged in administrative or ancillary economic activities

This refers to the establishments engaged in support operations of transportation, cleaning, repair/maintenance, preservation, to other establishments belonging to the same enterprise to primarily promote activities in water for end users, water for industrial users and sewerage.

361	WATER FOR END USERS, EXCEPT INDUSTRIAL USERS

3611	Water for end users, except industrial users

This class comprises establishments engaged in supplying water suitable for

human consumption, in response to general demand, using water mains or pipes and other facilities installed for the purpose of supplying water.

Establishments that supply water for irrigation are classified under Division A – AGRICULTURE AND FORESTRY [0131].

362 WATER FOR INDUSTRIAL USERS

3621 Water for industrial users

This class comprises establishments engaged in supplying water for industrial use, in response to general demand, using water mains or pipes and other facilities installed for the purpose of supplying water (except those that supply water for hydroelectric power generation or water suitable for human consumption).

363 SEWERAGE

3631 Sewerage treatment

This class comprises establishments primarily engaged in operating, maintaining, inspecting, and other work related to treatment and pumping facilities installed for the purpose of treating sewerage.

3632 Sewer maintenance

This class comprises establishments primarily engaged in cleaning, surveying and inspecting, repairing, and all other work related to drain pipes, drainage conduits, and other drainage facilities installed for the purpose of removing sewerage.
