### **What is CIES2014?**

CIES2014 is an official statistical data collection on the current situation of establishments within the territory of Cambodia, which is conducted by the National Institute of Statistics, Ministry of Planning, Royal Government of Cambodia. Its results will be used for the statistical purposes only.

### **What is Establishment?**

An establishment is, for example, a shop, a restaurant, a coffee shop, a factory, an office, a hotel, a school, and so on. It is situated in a fixed location, under a single management, and operates economic activities such as producing or selling goods or providing services.

### **Why is CIES2014 conducted?**

Due to the long interval of ten years between two decennial censuses: the 2011 and 2021 Economic Census of Cambodia, it is proposed to conduct the inter-censal economic survey in 2014 by the Royal Government of Cambodia with the assistance of the Government of Japan and Japan International Cooperation Agency (JICA). CIES2014 is mandatory under the RGC's Sub-decree of July 2010 on designated official statistics.

### **What are the purposes of CIES2014?**

- To obtain basic economic information such as the current situation of establishments and enterprises, and to disseminate these results to the public.
- To update development indicators for utilization in monitoring Millennium Development Goals (MDGs), National Strategic Development Plan (NSDP), the Rectangular Strategy, and other domestic and international policies. These policies will finally improve Cambodian people's life.
- To provide information on the changes in economic aspects within the past three years after the 2011 Economic Census.

### **Who are enumerated in CIES2014?**

About 10,000 sample establishments are selected based on a statistical method from 24 provinces within the territory of the Kingdom of Cambodia, and are enumerated. These samples include the following establishments: 1) all those with 50 persons engaged and more; and 2) two percent of those with less than 50 persons engaged. While almost all establishments are covered, street businesses and those in Agriculture, Forestry, and Fishery sectors are excluded.

### **What are the questions on the CIES2014 form?**

The form includes the following topics:

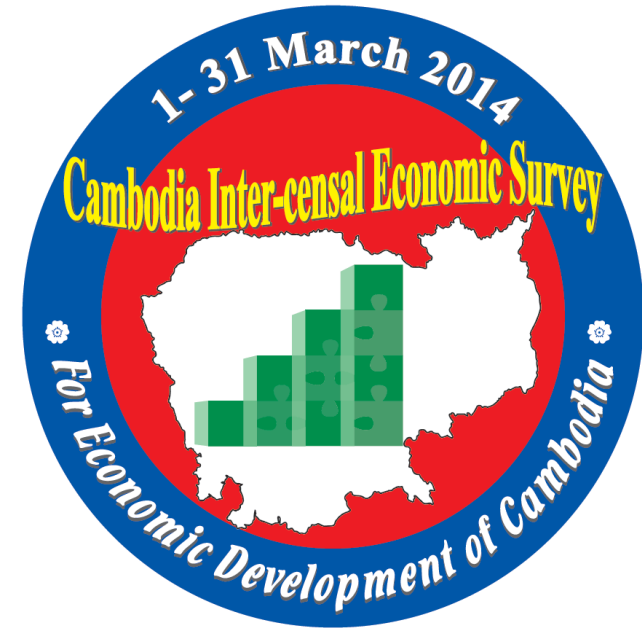
- 1) Name of establishment;
- 2) Address of establishment;
- 3) Characteristics of representative and owner;
- 4) Registration at administrative agencies;
- 5) Ownership of establishment (Legal status);
- 6) Business hours;
- 7) Year of starting the business;
- 8) Tenure, kind, and area of business place;
- 9) Number of persons engaged;
- 10) Kind of main business activities;
- 11) Single unit, head or branch office; and so on.

### **How is CIES2014 conducted?**

It is conducted on a sample survey basis. One enumerator is assigned to one selected village or one enumeration area (EA). The enumerator visits every selected establishment in the village or EA and asks the questions according to the CIES2014 form. In accordance with the Statistics Law of Cambodia, each selected establishment has obligation to answer truthfully all questions on the CIES2014 form.

- keep confidentially of the collected information; and
- keep the filled-out forms secured.

- cooperate with the enumerator to provide accurate answers to the topics on the form.
