 - **Opening Address** by **H.E. Mr. San Sy Than**, Under Secretary of State, the Ministry of Planning, and Chairman of the Meeting.
- **2. Mr. Long Chintha**, Acting Director General, the National Institute of Statistics, Ministry of Planning reported on the progress of the preparation for the 2014 Cambodia Intercensal Economic Survey (CIES2014).
- **3. Mr. Khin Sovorlark,** Deputy Director General, the National Institute of Statistics, Ministry of Planning reported on the revision of the CIES2014 documents as follows: (1) Outline; (2) Work plan; (3) Sample design; and (4) Revised form
- **4. Mr. So Tonnere,** Deputy Director of Department, the National Institute of Statistics, Ministry of Planning reported on two new works: (1) Mapping work; and (2) Outline of survey activities.

Discussion

H.E. Mr. San Sy Than mentioned as follows: Since the NIS will assess the Agriculture Census next month, the subject-matter staffs are requested to manage time available time for the CIES2014 activities.

Mr. Long Chintha, Acting Director General, asked two questions as follows: (1) Can you add one topic on persons engaged by age group into the CIES2014 form? (2) Can you add English words onto the CIES2014 logo?

Mrs. Pol Nearytola from Ministry of Commerce asked three questions as follows: (1) Can you add a representative from the Ministry of Environment into the CIES-TC? (2) Can you explain the definition of establishment? (3) Can you add both English and Khmer words on the CIES2014 logo?

- Mr. Yamauchi explained that we didn't need to ask the question on persons engaged by age group because it would become complicate. If we need this kind of data, we can derive from the results of the 2008 Population Census.
- Mr. Khin Sovolak explained that the establishment refers to a shop, a restaurant, a factory, an office... making economic activity under a single ownership or control at a single physical location. He also said CIES-TC has already been set up and enacted in Aug. 2012. With regard to adding a representative from Ministry of environment and making the logo bilingual, we will be submitted these matters to H.E. Mr. In Saroueng, Secretary of State, the MOP and Chairman of CIES-TC to make a decision.
- H.E. Mr. San Sy Than concluded this CIES-TC as follows: (1) He expressed thanks for JICA Experts and NIS staffs who prepared all the documents. Through these activities, the capacity of the NIS will become better and better; (2) Regarding the logo, he requested to draft many kinds of designs for selection and he will submit better ones to H.E. Mr. In Saroeung for approval; (3) He requested to utilize Cambodian Standard Industrial Classifications (CSIC) for the CIES2014 coding.

Finally he thanked to all the participants for having spent time to this CIES-TC.
