What is economic census?

Economic census is the census of economy through counting all entrepreneurial units in the country.

There are three major censuses:
Population Census;
Economic Census; and
Agriculture Census.

Application of Technological Advancements

- **1. Introduce e-Census to Enumeration** (first-ever in the official censuses and surveys of Nepal)
- **2. Introduce Tablet Computer to Enumeration** (first-ever in the official censuses and surveys of Nepal)
- 3. Use Satellite Imagery for Census Mapping
- **4. Decentralized Data Entry** (first-ever in the official censuses of Nepal)

The Census covers all areas throughout the country.

4. Enumeration Unit

The establishment as an enumeration unit for the Census is defined as follows, according to UN definition:

The establishment can be defined as an economic unit that engages, under a single ownership or control
that is, under a single legal entity - in one, or predominantly one,
kind of economic activity at a single physical location
for example, a mine, factory or workshop.

5. Coverage of the Census

The Census covers all establishments which exist at the reference date in the territory of Nepal.

The establishments, however, which belong to the following Sections of the United Nations **International Standard Industrial Classification (ISIC)** of Economic Activities, Revision 4 are excluded:

- a) Non-registered establishments classified into Section A, Agriculture, forestry and fishing; b) Section O, Public administration, etc.;

- c) Section T Activities of households, etc.;
 d) Section U, Activities of extraterritorial organizations, etc.

In addition, movable establishments such as street business which are doing business at the same place are included.
